Emergency Preparedness Plan - Rick

- 1. 2nd cache valued at \$3,552
- 2. Submitted grant request last week
- 3. Only an opportunity to get 4 caches (to be zoned in ~NE, SE, NW, SW Quadrants)
- 4. Caches
 - a. Rob has 1st cache (SE Quadrant covers Areas 8, 9, 11)
 - b. Jenny 2nd cache (NE Quadrant covers Areas 4, 5, 6, 7)
 - i. requires emergency preparedness plan
 - ii. Plan required before 2nd cache will be ordered
 - c. Neighbor of Rick offering to host a "stop the bleed" class (20 max capacity)
 - d. NW Quadrant covers Areas 1, 3, 10 next year
 - e. SW Quadrant covers Areas 2, 12, 13 (Quadrant) next year
- 5. Radios Mark
 - a. East/West partition will work for the radios
 - b. Be prepared to enter new privacy code
