

Palisades Neighborhood Resident Tool Kit for Lakeridge Student Street Parking

Palisades neighborhood residents and the Palisades Neighborhood Association are committed to maintaining safe neighborhood conditions for pedestrians and motorists. Below find examples of unsafe situations and recommended corrective actions for local residents. Some of the suggested corrective action includes copying **Lake Oswego School Board and Lake Oswego City Council**. This is advisable to gain visibility for our safety concerns and help make our Palisades Neighborhood voice relevant again.

1. **Speeding, reckless, unsafe driving or illegal behavior (drinking alcohol in or around parked vehicle for example) Call Lake Oswego police immediately**, a license plate number or vehicle description should be provided to the police when possible.
 - a. Next, call the Lakeridge office immediately 503-534-2319 and ask to speak with Principal or Assistant Principal to report incident.
 - b. Suggest a brief description of this incident be documented and emailed to **LOSB: losdschoolboard@loswego.k12.or.us and Lake Oswego City Council: CouncilDistribution@lakeoswego.city**. Include Principal Desiree Fischer and John Parke Assistant Principal: fisherd@loswego.k12.or.us, parkej@loswego.k12.or.us On this email.
2. **Student vehicles parked blocking your mailbox or encroaching your driveway.** The Lakeridge Administration has a 'good neighbor' policy in place for students blocking your mailbox (**parking within 10'**) or encroaching your driveway. Policy posted on PNA website.
 - a. **Take a photo of the vehicle showing its orientation to your mailbox**
 - b. **Take a photo of the vehicle license plate.**
 - c. **Email the photos to Lakeridge: elskej@loswego.k12.or.us** Per the policy they will identify the student from the plate number, pull them from class and instruct them to move their vehicle.
 - d. Suggest copying **LOSB: losdschoolboard@loswego.k12.or.us and Lake Oswego City Council: CouncilDistribution@lakeoswego.city**

Surprisingly, it is not a ticketable parking offense to block a residential mailbox in the City of Lake Oswego, also Clackamas County will not supersede Lake Oswego city jurisdiction.

3. **Illegally parked vehicle.** If you suspect an vehicle is parked illegally (too close or blocking fire hydrant, too close to corner of intersection causing wide unsafe turns, parked in fire lane or in a posted no parking area, as examples). **Call Lake Oswego Police non-emergency dispatch 503-635-0238** with location, description of unsafe condition and vehicle license plate number.
4. **Students littering trash.**
 - a. Email a photo of trash with your address to elskej@loswego.k12.or.us
 - i. Suggest copying **LOSB: losdschoolboard@loswego.k12.or.us and Lake Oswego City Council: CouncilDistribution@lakeoswego.city**
5. **Excessive noise from vehicles (mufflers or stereos as examples).**
 - a. **Call Lake Oswego Police non-emergency dispatch 503-635-0238** with location, description of condition and vehicle license plate number.
6. **Students verbally disrespectful to local residents.**
 - a. Call the Lakeridge office immediately 503-534-2319 and ask to speak with Principal or Assistant Principal to report incident. Best if you can associate student(s) in question to a vehicle license plate for identification.
