Earl Hall – proactive policing slowed down during COVID, now present and actively looking for violations, driving behavior has changed after COVID, LO has enforcement so accountability here is better – 2 motor officers, soon to be 3 motor officers (specifically assigned to traffic enforcement) usually have 4 patrol officers at any time, and a detective unit, etc.

#### **AUTO vs. PED CRASHES 2023**

02/01 at Quarry Rd / Collins Way; Ped (78yr) was walking east bound on Quarry Rd. Driver didn't see Ped. Ped was struck by east bound vehicle on Quarry Rd. at about 15mph and sustained minor injuries. Driver was cited for ORS: 811.135 Careless Driving.

03/22 at Foothills Rd / N. State St; Ped (25) was walking on the sidewalk when a vehicle pulled out of a driveway and struck the ped on the sidewalk. Ped sustained injury to ankel and bot. Driver was cited for ORS: 811.025 Failure to Yield to Ped.

04/21 at Lake Ridge High School parking lot; two Peds both 15, had minor injuries due to JUV driver. Driver was estimated to be traveling at about 40mph in the parking lot and was unable to stop for peds. Driver was refered to Juv Dept for ORS: 811.140 Reckless Driving

### E-Bike Enforcment

On 07/06/2023 Lake Oswego Motors completed an E-Bike Enforcement Mission. Several E-Bikes were stopped for sidewalk violations, and carless operation of a bicycle. All riders were underage and operating an E-Bike with no op. Parents were contacted in all circumstances and educated on the following Oregon Revised Statutes.

ORS: 815.280 Required Lighting Equipment

ORS: 814.420 When to use bike lanes

ORS: 814.400 Application of Vehicles Laws to Bicycles

ORS: 814.410 Unsafe Operation of Bicycle on Sidewalk
