


Will Farley - Traffic Engineer, Lake Oswego

- Specifically for public right of way
- CE for over a decade

- Branch of civil engineering
- Responsibilities
 - Review/critique with traffic studies
 - Review engineering plans
 - Temporary traffic control plans
 - Capital improvement projects
 - Liaison to City Advisory Board
 - Traffic signal operations
- Common Concerns
 - ○Speeding feedback sign
 - Remediation
 - Speed bumps (subject to scoring system)
 - Signage

 - ○2007-2023 trending relatively flat on South Shore
 - Fernwood

- Question re: Lakeridge High School parking
 - ODoes Traffic Engineering talk with the School Board about long-term plans and vision?
 - ○Can't control parking within a public thoroughfare
- E-Bikes
 - ○16 & over
 - Not on sidewalk
 - Helmet recommended
 - Sergeant Earl schools have been very receptive to cooperating on regulating e-bike use
 - ∘ Q: can the police ticket e-bike users?
 - A: yes if violations are observed
 - Had a lot of success partnering with the schools
 - ONote: e-bikes are not allowed at middle or elementary schools
- Question from Deborah Wilkinson

We have been trying to restrict parking on Marjorie/Koawood, and Banyon. We have been told this will not be possible. Can you confirm this and explain why this is. Our streets have become very dangerous.



• Very cautious of restricting parking because it often has negative consequences

- Will: Over-engineering creates its own set of problems
 - Example: stop signs that people just roll through
 - Tends to back-fire
 - Non-compliance increases when solutions are over-engineered
- Working on traffic safety concern form
- Comment from Marjorie Lewis...

Marjorie/Koawood/Banyon parking North of Lakeridge Football field. Keep in mind no sidewalk for students exist so students speeding on Fernwood prior & after school presents danger to pedestrian. In October 2022 my Prius parked in my driveway was totaled by a hit & run driver. I am located corner of Fernwood & Greentree Ave. My ring camera facing Fernwood (I am 1 block away from the high school) shows students walking in the roadway while student drivers speeding by. Just a matter of time before we see injury.

- Sergeant Earl: Don't get discouraged. Police and City coordinating with a lot of constituents.
 - ○2 motorcycle officers in whole city
 - Only effective in consultation with residents in the area
 - People tend to be worse drivers next to home
- Deborah Wilkinson follow-up question...

A follow up to my devious question. We had been told that we could restrict parking our street if we were able to achieve 100% agreement on the restriction. Now we are being told that is no longer possible. Is that true and why is that?

Not sure what the City's policy is now regarding 9-3 parking restrictions in school zones
